Anne made motion to approve the minutes from last meeting, Doug seconded, all in favor.

Treasurer's Report- Anne reported we have \$11,883.28 in the bank. Diane moved to accept the report, Doug seconded, all in favor.

Frank reports Region 3 meeting was last month. They talked about some local lake issues.

Weed Control Contract- Frank signed the contract and gave it to Aquatic Weed and shared it with Don. It is all signed and finished. Frank told Anne she should be receiving a copy of their liability insurance. Anne will be on the look out for it.

Board Member Nominations are coming up in November. There are 3 Board openings. Anne, Doug and Dona's positions are up for reelection. All of them wish to continue on the Board. We will send a notice to the membership that nominations are open. We shall receive other nominations at the November meeting.

Weed Control- Don said the contract is all settled. There is a slight increase in the permit amount but the other price is the same. The special assessment has been approved by the township.

Weed Boat- Doug had nothing to report, it was never used this year.

Village Updates- Roman said the Dam project is moving along. It should be done in December and have some spring work. The wooden bridge will be added in the spring. In their digging they found some old timbers from the old Mill and a lumber yard that was at that site years ago. They also found an old road sign. We have them setting these things aside. The Maple Lake bridge will be done in November. It is the same height as the old one. There will be 4 fishing stations on the bridge as well. The bathrooms are being winterized and they are looking at the piers near the boat launch to see if they can level it better. He needs a \$20 check for filing the annual report. We will reimburse him.

Website- Dona reports the website is doing well. Similar flow on email openings and correspondence. Our facebook page is doing well and we have had about 287 views in the last month. Dona will continue to post things on the facebook page as well as the website.

Hats, Visor, Shirt sales-Diane reports no sales this month.

Grants- Sue not here tonight

Communications- Mike said he had gotten the emails from Anne about EGLE trainings and conferences etc. He will look at any grant opportunities.

Anne suggested we may need a social committee to discuss events membership can participate in. We will discuss further next month. Shirley said her MLSA membership is expiring in October. Anne will investigate.
